

Purpose

The International Laser Display Association ("ILDA") seeks to advance and promote the professional application of laser display:

- By maintaining standards of safety performance;
- By promoting a better understanding between laser display professionals and regulatory agencies;
- By fostering the development of new technology;

- By promoting the advancement of laser artistry;
- By increasing public awareness;
- By providing information to the public; and
- By promoting cooperation within the industry.

In order to fulfill this purpose, the organization may occasionally request that Artists contribute artistic works or other artistic data which could include frames, animations, cues, and/or shows used in a laser display ("Artistic Material") in order to develop, test, or promote technical features of ILDA Standards; educate or train industry on safe use of lasers in the art; raise public awareness of laser artistry or technical standards; or facilitate artistic cooperation and collaboration within the industry. Providing Artistic Material to ILDA is always voluntary.

Intellectual Property Statement

ILDA recognizes the importance of protecting the intellectual property of Artists and by extension, the intellectual property of third-parties that may have been included as part of the Artists Artistic Material.

ILDA's Bylaws, Code of Ethics, and/or Code of Business Practice provides ILDA's expectations of its Membership when conducting business or displaying their work. ILDA asserts that it makes a good faith effort to obtain diligent and honest information when seeking Artistic Material from Artists in order to fulfill its purpose.

We rely solely on the information supplied by the Artist when evaluating where and how a specific contribution of Artistic Material may be used, distributed or displayed. Artistic Material containing cues, frames, animations, stock content, or other material may be subject to the licenses or permission of third-parties. ILDA advises that the Artist check with the provider of these elements to determine if additional licensing or permission is needed
